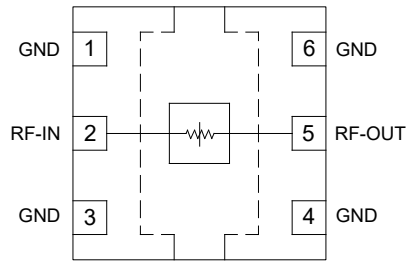


Figure 1. BAT-3+ Functional Diagram

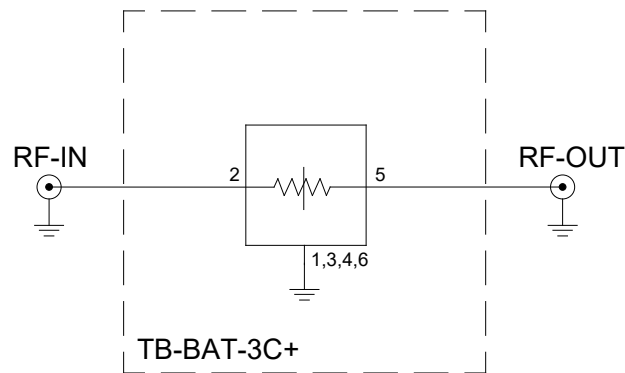


Figure 2. BAT-3+ Characterization and Application Circuit.

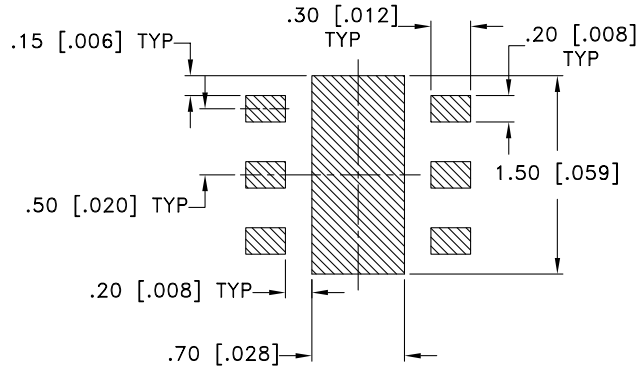

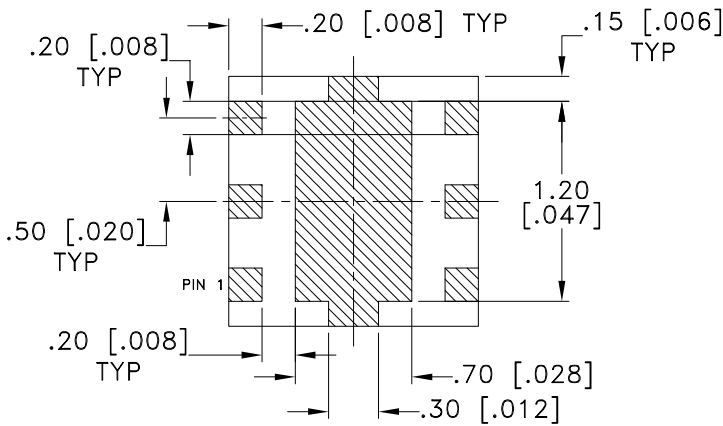

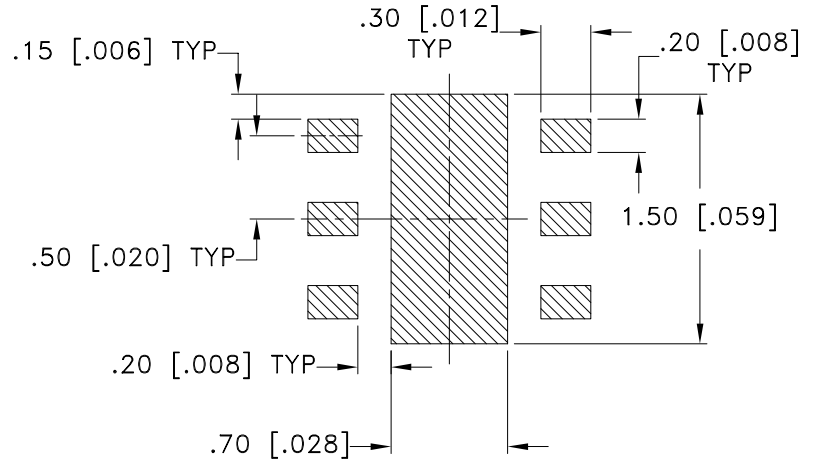


SIDE VIEW

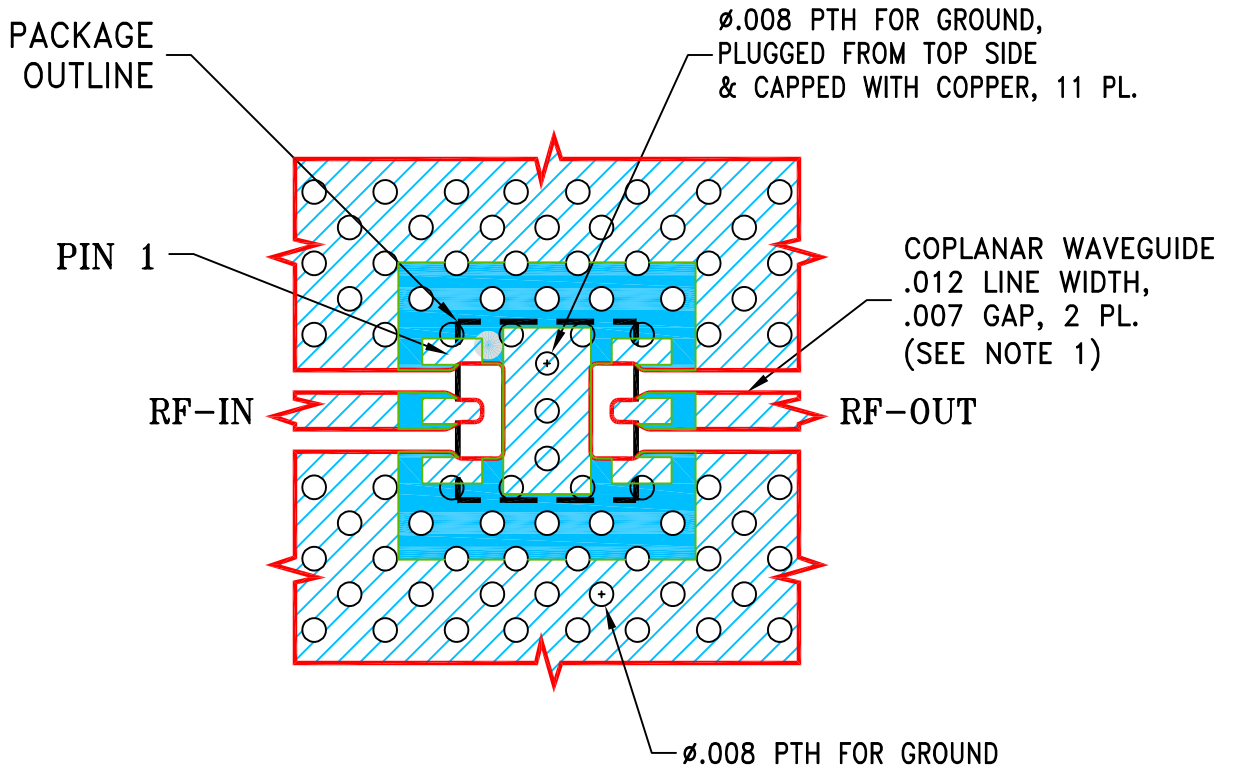
