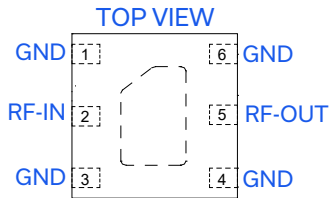

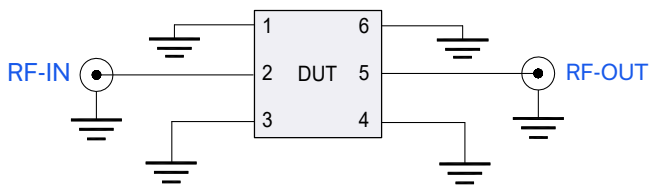
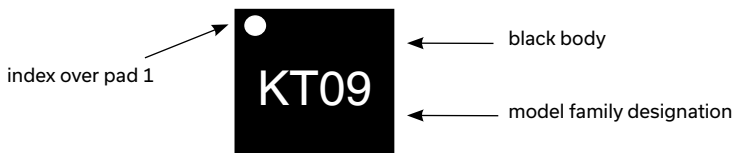


Fig 1. Block diagram of Test Circuit used for characterization, Test board TB-934-9C+ Conditions: Attenuation, VSWR: Pin=0 dBm

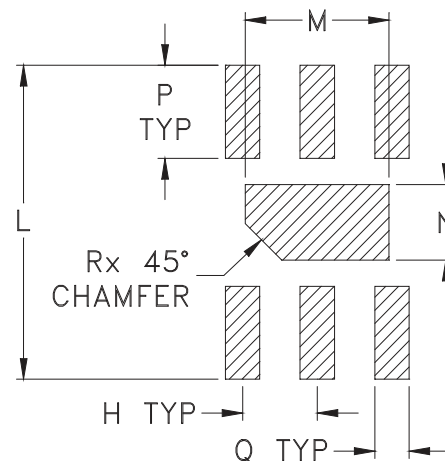
Typical Performance Curves

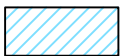
